## **Description: Confined Space Resue Technician**

This course is an intensive hands-on training program that will prepare you to respond to confined space emergencies. This course of instruction prepares the student in identifying; confined spaces and permit required confined spaces, the hazards associated with permit required confined spaces, targets industries and hazards, state and federal regulations, components of a rescue operation, and the roles and responsibilities of the rescue team.

**HazMat First Responder Operations (SFT)**

**IS-100, IS-200, IS-700, IS-800 (FEMA- online)**

**Bring:** USAR TDU's, Wildland PPE, or coveralls, work gloves, boots, low profile helmet, flashlight, flash hood, knee/elbow pads, fluids for drinking, and Scott SCBA mask if available.
