**Description:** This hands-on course provides the knowledge and skills needed to minimize errors on the fire ground and reduce fire fighter injuries and fatalities including calling Mayday; SCBA and air management; and navigation, disentanglement, wall breach, anchoring, window hang, ladder escape, and above and below grade survival techniques.

**Pre-requisites:** Fire Ground Survival Awareness (IAFF – online / Must be completed within 90 days of SFT course start date.)
